Memorandum of Understanding

And

hereby confirm their intent to enter into an agreement to participate in NIIT's Program to broaden the horizon of learning for students beyond the university curriculum with the objective of enhancing employability of the students.

Under this program, NIIT will offer to the students of the College, Skill Enhancement Training Program for the 1st/2nd / 3rd year students passing out in 2015/2016/2017 respectively.

The following are the broad terms of agreement:

1. Commercial Terms:

- Fee: College will pay NIIT the following fee per student for the stipulated hours of the training program to be conducted over a period of 365 working days covering respective hours of training.

- The above fees offered to HMV is a special price for respective programs and will remain fixed for the term of the agreement (1 year). Further if MOU is extended fee may vary



- c. **Number of Students:** HMV expects to initiate the program in the current academic year 2020-21 in the month of August for its 1st, 2nd and 3rd year students and will offer it to a minimum of 100 students. Additional students if any; would be charged on a Pro-rata basis as per respective program.
 - d. **Payment Terms:** College will pay 100% of the fee to NIIT Ltd payable at New Delhi in advance for the number of students for respective programs opted by the students from different branches.
2. **Feedback:** there would be a feedback conducted by NIIT every 10 days and the consolidated report would be shared with the college. Based on the feedback corrective actions, if deemed necessary will be taken by NIIT or the college as the case may be to ensure effective delivery and quality of the program.
 3. **Scheduling:** It is College's responsibility to provide an enabling schedule for NIIT's training program.
 4. **Infrastructure:** College to provide all requisite infrastructure in the form of Classrooms, Labs with all relevant software and hardware, including projectors as per the specifications as shared by NIIT.
 5. **Trainers:** NIIT will depute the necessary number of trainers on campus for facilitation of the classroom and lab sessions.
 6. **Courseware:** NIIT will distribute courseware to the students at the start of training program as applicable.
 7. **Certificate:** NIIT will provide a program participation certificate at the end of the NIIT program to each student.
 8. **Contact Person:** In order for NIIT to start work on equipment installation and timetable planning, the single point of contact from the college for all discussions will be Mr / Ms Rekha Kalia Bhardwaj, Pr a designated official of HMV.

Memorandum of Understanding

This MOU is executed on the day and date set out hereunder on the general conditions regulating the relationship between

Reliance Money Infrastructure Limited, having its registered office at 570, Rectifier House, Naigum Cross Road, Next To Royal Industrial Estate, Wadala, Mumbai - 400 031 which expression shall mean and include its successors and assigns (Hereinafter referred to as "the Company",)

Relationship-

Eligibility:

1. It is understood that this training program is made available only to those students who are enrolled with the Institute/ University and continue to be enrolled as a student of the Institute/ University, during the entire term of the training period.

Status of the training -

The Institute / University shall take all steps necessary to communicate to its students the details of the training program, including the terms and conditions governing the same.

During the training period, the students shall be subjected to Company rules and regulations, especially with respect to training program. Each of the students enrolled for the training program is required to confirm and accept the terms and conditions as applicable to the training program.

Training Module Fees-

Each of the students enrolled for the LEAP- Learning and Employability Advancement program shall pay fees as specified from time to time by the company and the fees shall be payable in advance to the company at the time of enrollment. The fees once paid shall not be refundable under any circumstances.

On Ground Training - OGT

The company shall impart On Ground Training to all students enrolled in its program and may depute the students to any of its offices, branch locations including any of its group companies for On Ground Training Program.

Term-

This arrangement shall be valid for a period of 2 years from the date of execution of this MOU and shall stand renewed for a further term of one year each, until otherwise terminated by the parties hereto, upon written notice of at least 30 days.

Non-Compliance –

In case of any non-compliance with the rules and regulations by the students, the Company reserves its right to discontinue the training program in consultation with the Institute/University and inform the Institute/university accordingly.

Employment-

The Company does not assure and or guarantee any employment to the students enrolled to the training program.
The company assures that it would be conferring a preference for placement opportunities to all such certified students by it as and when such placement opportunity arises.

Rights of the Company And Institute-

The Company and Institute reserves its rights to extend, modify, change, cancel, discontinue, and withdraw the terms of the training program upon mutual consent with 30 days notice at anytime during the term of the training program with mentioning of a reason.

Confidentiality-

The parties hereto shall keep strictly confidential all technical, business and other information including but not limited to that which may be disclosed or confided to it by the other in the course of the performance of its duties and obligations under this arrangement.

Relationship between the parties:

Nothing contained herein shall be deemed to create any association, partnership, joint venture or relationship of principal and agent or, master

Advertisement-

All instructions, rules, terms and conditions on any advertisement or promotional materials relating to the training program shall form part of these provisions, provided that in the event of any conflict or inconsistency, these provisions shall prevail over all such other instructions, rules, terms and conditions.

Complaint resolution-

The parties hereto shall address the issues, concerns and complaints through mutual discussion, consultation and cooperation.

Jurisdiction-
