



OFFICE WORK POLICY

A. Late Coming relaxations:

1. No standard deduction will be applied for the first two instances of late arrival up to 10 minutes.
2. Starting from the third occurrence, an extra late coming deduction (3 Hours) will be enforced.
3. If late arrival exceeds 10 minutes in the initial two occurrences, regular late arrival deductions will be applied without any leniency. The first two allowances are applicable solely for delays less than 10 minutes and are valid only during the initial two occurrences.
4. If there are no instances of late arrival, early departure, gate pass requests, or half-day occurrences in a given month, an attendance bonus of Rs. 2000/- will be granted.

B. Short leave availment:

1. Employees are entitled to two short leaves per month.
2. Short leaves are unpaid; standard deduction rules apply.
3. For the first short leave in a month, no advance notice is required.
4. To avail of a second short leave, employees must inform their Head of Department (HOD) at least one day in advance.
5. Short leaves can be availed to waive the 3 hours deduction.

D. Termination terms


